A proposal is presented, consisting of an information meeting for students on October 20^h and on written information to be made available on canvas.</p>	<p>The group approves this proposal.</p>
<p>§8. Course syllabi at the revised Programme HT2023</p>	<p>Roger Johansson informs about the syllabi of the new courses within the programme. All syllabi should be prepared for approval before October the 11th. Lindsey Macke notes that the web pages will need some updating to reflect these changes.</p>	
<p>§9. Looking at VT2023, 53 students to supervise.</p>	<p>This year 53 students will engage in thesis work that will require supervision. The members discuss how the supervision needs may be accommodated in the best way. Discussion on the possibility for the students to write their theses in pairs as a solution to this issue. It is emphasized that students should start with LU supervisor contact/approval before involving outside connections in thesis work</p>	
<p>§10. Other business</p>	<p>The meeting discusses that the procedures for assigning course leaders within the programme should be the outcome of communication and discussion between the director of studies and the programme leadership.</p>
